These included lightly sanding and applying a thicker and hopefully more durable sealer on the Great Hall and Dining Room floors; placing new posts along the front driveway to help prevent vehicles from driving on the front lawn; building a new brick barbeque grill off the front porch; putting a larger refrigerator in the night kitchen; and installing speakers and refinishing the bar top in the Activity Room. Tim also had to deal with the removal of one of our ancient oak trees on the front lawn that finally succumbed to a severe storm.

In addition Butch and Tim followed up on the end of school year check out lists and did any touch up painting and cleaning required for each of the study rooms. All the hallways and bathrooms were also thoroughly cleaned.

As I was moving into the house for the upcoming semester, I was taken aback at how beautiful the house looked (not that it wasn't before). All of the floors, walls, furniture, and everything else still look brand new. I would like to thank the House Corporation and especially Butch Brose (our Maintenance Coordinator) and Tim Maloney for getting things ready over the summer break.

Four other officers and I attended Balfour Leadership Training Workshop over the summer, and we had a great experience. Our chapter was awarded its 11th straight Peterson Award which goes to the top 15% of all of the chapters. The next longest streak for Petersons won is six in a row. We also got a chance to sit down and layout our plans and goals for the upcoming school year while we were at BLTW. Our main goal for the year is to raise \$5,000 for Derby Days which is guite a bit more than what we have raised the past few years (around \$1,500 a year).

"May those men in the future of our Brotherhood appreciate the tokens of our great House's history and its contribution to all of our lives," noted House Corporation President Harold Force '73 as the sealed bags of Delta Delta historical materials were placed

in the copper liner and inserted into the cornerstone marked "2007". Four days later on July 10th this corner-

stone was set in place by a local contractor and sealed for posterity for future generations of Delta Delta brothers.

The process of filling the 2007 Cornerstone began at this year's annual golf outing on June 7th when many alumni brothers gathered back at the renovated chapter house. Prior to dinner, a ceremony was held placing key documents and photographs from the *Campaign to Secure*

the Future of Delta Delta in the cornerstone container. Jim Dora '58 and Bernie Sergesketter '58 placed a complete set of campaign materials into the copper container that would eventually be welded shut and placed into the 2007 cornerstone.

In his remarks, Brother Dora lauded the Building Committee and the exceptional efforts of Harold Maloney. and Tim Sergesketter commented about raising the \$7.4 million needed for the project and voiced his appreciation to Phil Steele for providing the outstanding data base and key knowledge of the alumni which were critical to our success. He thanked the Era and Class Leaders, the members of the Campaign and Steering Committees, the undergraduates, the 861 contributors, and Pennington & Company for their excellent advice.

In addition to the campaign materials provided by Bernie and Jim, Ralph Bline compiled other historical items including documents from the 125th Anniversary Celebration, and Delta Delta Datas

highlighting some of our chapter's history. Copies of the contents from the 1912 Cornerstone were also placed with the more recent items. The precious materials for the time capsule were placed in hermetically sealed, chemically stable plastic bags, and inserted into the copper box which was then soldered shut. The

Call To Order

House Corporation President Harold Force called the annual meeting to order and thanked those present for attending.

Old Business

Harold Force referred to a copy of the 2007 minutes distributed to each person in attendance and asked for approval of these minutes as written. It was moved, seconded and approved.

Finance Committee Report

House Corp. Treasurer Scott Brenton updated the chapter on the current financial status of the House Corp. Scott noted that signed contracts had been received from all live-in brothers, and that 51 of 57 brothers were paid in full. Payment arrangements are in place for the others. Operating procedures for handling security deposits still need to be formalized.

All House Corp., Alumni Relations, Scholarship and Chapter accounts have been consolidated at 1st Source Bank in Lafayette. This allows for consolidated reporting and better oversight of these funds. Our current balance in all accounts is \$201,301 with a remaining reimbursement of \$27,950 due the undergraduates.

Campaign Fund Raising Report

Bernie Sergesketter reported that from the total of \$7.404 million, \$1.809 million was still due from pledges. Early payment of pledges was being encouraged to reduce finance costs. Our loan was refinanced lowering the rate to 6.28%. The Chapter House renovation project has received national recognition from Purdue and Sigma Chi Fraternity as both have run stories in their publications on our campaign.

Legal Committee Report

All corporation paper work is current. Next up: Compiling new House Corporation By-Laws.

Scholarship Committee Report

This committee established procedures and applications for administering the \$2500 scholarships for both the Purdue and Sigma Chi Foundations. 59 brothers received these scholarships in 2008/2009.

House Committee Report

Tim Maloney reported that this group under the guidance of Butch Brose (our Maintenance Director) has continued to work well with the actives and pledges to maintain the chapter house, address warranty issues, and take care of routine repairs and clean up. Over the summer several large projects were undertaken. These included

- Refinishing the Great Hall floor
- Storm water drainage was reworked on the north side of the house
- Guard posts were installed along the edge of the driveway
- Installed new under counter refrigerator in night kitchen
- Reworked the bar countertop and installed new speakers in the Activity Room
- Cleaned, patched and painted student and public rooms as needed
- Removed large tree in front yard damaged by storm

Built new grill at edge of East Patio

Projects for the coming year are to formalize "check-in and check-out" procedures, put together a House Manager's Operating Manual, and emphasize the proper performance of wake duties.

Archives Committee Report

Ralph Bline oversaw the compilation of Delta Delta items placed in the Chapter House 2007 cornerstone. The cornerstone was set in July following the dedication ceremony held at the Alumni Golf outing.

Professional high resolution reproductions were also made of the Delta 1875 charter and the two original McCutcheon prints that were on display in the Library. The originals are now stored in the Archives Room. Ralph also assembled a display of Renovation Project photographs which were displayed at Homecoming. Ralph is also beginning the arduous task of chronicling Delta Delta's valuable artifacts and memorabilia.

Phil was also presented the Philip Bowers Award by Purdue's IFC as the outstanding chapter advisor in 2007-2008. The many alumni present also honored Phil with a monetary gift to recognize the time and commitment he (and his wife, Cinde) have made to Delta Delta.

The Delta Delta Scholarship fund awarded \$700 to five undergraduates for academic achievement.

Undergraduate Chapter Report

Consul Matt Gadus reported that the chapter had initiated 33 new brothers last spring; that they had 30 members in this year's pledge class, had received their 11th consecutive Peterson Award at the Balfour Leadership Training Workshop in August, had ranked 2nd (1st semester) and 6th (2nd semester) academically, had raised the most money for the Drew Brees Challenge, and senior Chris Horney had been selected as the Northern Indiana Province Balfour recipient.

Election of Directors and Officers

George Ade Remembered By Wandering Brother

Ade gravesite in Kentland, Indiana

Jim Chapin '68 recently visited George Ade's home "Hazelden" that sits beside the Iroquois River three

miles west of Brook, IN along State Road 16. It's a picturesque site that has been preserved to reflect Ade's years at his beloved home. Tours are available, but need to be arranged ahead of time.

Following this stop, Jim headed west and turned south on Highway 41 and drove through Kentland, birthplace and boyhood hometown of George Ade. Jim notes that he had read that Ade had chosen to be buried in the Ade family plot in the


Kentland City cemetery south of town. Less than a mile out of town Jim could barely see, rising above the cornfield, the tops of a few tall tombstones. The Ade family grave site is visible upon entering the gated cemetery. Arranged in a semi-circle around the massive Ade monument are the individual Ade family members grave stones with George's in the center. Each stone lists only the individual's name, year of birth and

year of death. Jim was surprised not to find any marker or stone inscription documenting Ade's ac-

complishments, philanthropic endeavors, honors, and the organizations that he devoted his life to. Ade $\Delta\Delta$ 1887, along with his life long support of Delta Delta, also served as Sigma Chi's 14th Grand Consul from 1909 to 1911.

Jim reflected as he stood at Ade's gravesite about how many Sigma Chis had visited this site, and he wished he had

brought a single white rose for his grave. Brother Ade died on May 16, 1944 at age 78. All Honor To His Name.
